- Please remember that CAMS needs to have a key or a code to access your unit in an emergency. If you change the key or the code, please advise the CAMS on site management team and provide this information.




# **MEET OUR NEIGHBOR**

## **FINANCE COMMITTEE**

The Finance Committee met on Thursday, May 13, 2023 at 5:00 pm with the COO, CFO, Regional CAMS Supervisor and accountant to discuss accounting practices as it relates to the financial statements that are generated by the CAMS accounting software.

Several questions were submitted in advance of the meeting but some discussion during the meeting clarified the questions. A follow-up meeting will be scheduled as soon as the CAMS accounting staff has time to prepare a full response to our questions.

Additionally, there was a discussion about the prompt processing of a lien and foreclosures on units whose owners who are delinquent in their HOA dues by 60 days. The Board of Directors has approved a change in the law firm that will handle the collections process in an effort to keep to a timeline that will avoid having to foreclose on properties.

The hard work of the finance committee will begin in earnest in June as we begin to develop the operating budget for 2024. #### **BEACH PROTECTION COMMITTEE**

The ODHOA Board has signed a contract with MS Consultants to help us with the advocacy work needed to try and obtain a grant towards protecting our beaches and property from erosion and damage. Thanks to the committee for all their work and efforts. This committee was created in January 2022 and has done great work to get us this far.

#### **BUILDING COMMITTEE**

Board member Evan Wittles is spending many days overseeing the work and preparation for work at Ocean Dunes. Because of his experience and expertise, he is the right individual for the job. He is in contact with contractors and fellow board members on a daily basis.

The repairs, replacements, and landscaping of the area between the Rec Center and the 2200/2300 buildings are complete. No more an "ankle breaker" walk, says Evan. And so attractive.

Adrian and his crew are "at it," replacing the joist hangers. Many have been done and they are keeping at it at a fine clip.

The 2200 elevator is on schedule, to be completed mid-May. "Let's keep our fingers crossed."

An extraordinary amount of upgrades as well as maintenance are being handled by the Ocean Dunes in-house crew including street signs, number signs.

Evan notes that during the dryer duct cleaning it was discovered where there had been an unreported fire in a unit, resulting in singed walls and the duct work burnt completely through. He says this didn't happen in a short period of time and surmises it was over more than a couple of past cleanings and inspections. He attributes this to having had cursory cleanings by the past company. He commends the board for insisting on a change in contractors to a company with a strong reputation for thoroughness. He hopes this kind of change continues with the board changeover.

## LONG RANGE PLANNING COMMITTEE

The LRPC last met on 2/13/23. We reviewed the 2023 project list and updated all projects with the latest estimates and timing that we have obtained to date. The project list with updated notes for 2023 is as follows:

• Concrete – walkway repaired at 2200, more work planned for the Fall 2023

• Building paint/repair/lights – SKA scopes in progress for blds 500 and 1500. We should have the scopes soon. After reviewing the scopes, they will go out for bid.

• Building paint/Decks/structural repairs – SKA scopes in progress for blds 100 and 1000, Will include full paint/repair/deck rebuild/lights. Same as above, once scopes are received and reviewed, they will go out for bid.

• Structural inspections – UCC to provide est, will split work between Spring and Fall. SKA engineers discovered many structural issues during their review, including broken hangers and decks on the 1000 building that needed to be addressed. This has been addressed w a temporary fix until the deck rebuild. UCC has been deployed to replace broken hangers on all buildings needing them.

- Elevator Rebuild-work is ongoing and timing is according to schedule.
- Pool heaters pool heaters received, will begin work soon.
- Pool pump filtration the filters are in good shape, we will hold on this until either fall 23 or spring 24.
- Rec ctr hot water heater we have the estimate and will begin work soon.
- Replace light safety fixtures. BFPE reviewed and work ongoing.

• Replace pool dehumidification system. – SKA reviewed, proposal submitted for review and estimate.

- Repair saunas complete.
- Mechanical/electrical/plumbing repairs purchasing new meter boxes for replacement.
- Resurface outdoor pool decks. TBD

We will meet in May once we get the building scopes and estimates. Our focus will soon turn to capital planning for the 2024 project list. We will continue to follow the plan for 2023 and 2024 that was put forth by G&F Engineering when completing our reserve study.
