

### A Day Trip from Ocean Dunes: The Green Swamp Preserve

If you are looking for a hidden nature park in North Carolina, head to the uncommon Green Swamp Preserve — one of the most unique places to visit in the Brunswick Islands. Here you'll discover magic in the insectivorous plants and the dense evergreen shrub bog, an environment made possible by the longleaf pine savannas. Another reason to drive to Supply is its lovely location at the intersection of Ocean Highway and Southport-Supply Road. To be sure — this is one of the most unusual places on the planet.

The Green Swamp contains some of the country's finest examples of longleaf pine savannas. The open savannas have a diverse herb layer with many orchids and insectivorous plants. Almost 13,000 acres of the preserve, however, are comprised of a dense evergreen shrub bog (pocosin) dominated by gallberry, titi and sweetbay.

The Green Swamp contains at least 14 different species of insectivorous plants, including extensive populations of Venus flytrap, sundew, butterworts and bladdeworts, and four species of pitcher plant. The preserve is also home to many rare animals, including the American alligator, Henslow's sparrow, Bachman's sparrow and Hessel's hairstreak butterfly.

#### HISTORY OF THE PRESERVE

Federal Paper Board donated 13,850 acres of this preserve to The Nature Conservancy in 1977 and an additional 2,577 acres in the late 1980s. The Nature Conservancy has since purchased additional land in the preserve.

### **Strawberry Shortcake**

Creating shortcake may seem daunting, but it doesn't have to be. I'm living proof as, for >ten years I prepared it for an every-growing hoard of hungry coworkers at my job.

> **Strawberry Shortcake** (serves 4-6)

6 cups strawberries, stems removed and sliced, 1.5 qt.

1 cup white sugar

21/3 cups original Bisquick baking mix, or any brand (Southern Biscuit mix at the CB Food Lion is the best.)

1/2 cup milk or more

Cap and slice strawberries. Sprinkle with 2/3 cup sugar. (I mash them a bit with a fork.\*) Refrigerate while making the shortcakes.

Follow package instructions for biscuits, adding 1/3 cup sugar to the dry ingredients.

Drop 4-6 big spoonfuls on baking sheet.

Bake in preheated 425F oven for 10-12 minutes.

Cool and halve horizontally.

A big spoonful of strawberries on each bottom, replace top.

Big blob of whipped cream.

Another big spoonful of berries.

**Long Range Planning Committee Update - 06/26/2024** 

The LRPC will next meet in July as we begin planning for the Reserve Fund portion of the 2025 budget. We will review project costs for 2024 and use that data to estimate what we expect costs to be for 2025. We will continue to follow the plan as laid out by Reserve Advisors for our RF long term plan. Some of the larger projects for 2025 include more building/paint/redeck projects, and a plan for the Recreational Courts (Tennis and basketball). We will be looking to form a sub-committee for the rec courts as this project will require multiple estimates and have multiple issues associated with it. # FINANCE COMMITTEE



The Finance Committee met on Monday, June 24, 2024 at 7 pm and discussed the June Balance Sheet, the Income Statement, and our current investments.

I am glad to report that we are under budget in General Maintenance. The HOA has earned approximately \$15K in interest so far this year on our investment in high-yield CDs. Also, to date the HOA has collected \$11K+ in late fees and interest. The CDs will begin to roll over at the end of this month. At the end of July, we will continue to invest in ladder CDs in the amount of \$50K per month.

The electrical surge that was created by an auto accident on 5/19/2024 damaged the A/C unit on the 2100 elevator (already repaired) and the A/C and elevator at the 2200/2300 buildings. The HOA has insurance for mechanical items and has submitted a claim for damages. Fortunately, the deductible is only \$5K for this claim. We still await the determination on the claim by the insurer.

In order to not file claims under our general policy for two major water leaks, we have paid \$70K and \$50K (approximately) out of the self-insured fund to cover the damages.

Next month the committee will begin the process of developing the 2024-2025 budget. Before we even begin the process, we know that based on the reserve study, we have to increase the Reserve Fund dues by 3%, which is approximately \$15/month on average.

We have paid for the total overhaul of the 100 building and paid for the paint and repairs to the 500 and 1500 buildings. The next step will be to fund the total overhaul of the 1000 building in the fall.

# BUILDING COMMITTEE

Buildings 100, 500, and 1500 are completed except for the details commonly entailed with large projects.

Preplanning for the overhaul of 1000 this Fall is in full-swing with bids being received, the engineer plans on the table, and discussions among the board.

As for elevator in the 2200/2300 building, replacement is a long work-in-process. Because the elevator was hit by a power surge, damaging electronic and other parts, there is no quick fix. Its demise was on a Sunday and there were the appropriate people looking at it the following Monday, and the insurance claim filed that Friday. There has been no foot dragging in getting it replaced. Organization was immediately set in motion for the repairs/replacement. Understanding that there is no band-aid is important. This is a priority understood by all involved. The elevator equipment rooms on both sides of the street had their power blown and the air conditioners rendered inoperable. Because temperature of the equipment must be kept within a specific range, this had to be dealt with post haste. Protecting our property has been the aim throughout this process with the insurance company. Bottomline: Replacement of the elevator and all that entails is going as quickly as possible. Ocean Dunes is fortunate to have the Delaware Elevator Co. district manager making this his priority, too.

The indoor pool duct work is finished and the major heavy duty equipment is set up for the dehumidification system of be installed. The project electrician will be doing his thing including digging the trenches on the exterior of the building for the laying of the new cable. This project is moving at a faster pace than expected.

The ever present day-to-day stuff, including individual concerns, are being handled as they arise, with this many units being compared to maintaining this many domiciles.
